3 **Ordinance authorizing settlement of the lawsuit filed by Sandra Teixeira against the**  
4 **City and County of San Francisco for \$162,500; the lawsuit was filed on October 26,**  
5 **2023, in San Francisco Superior Court, Case No. CGC-23-609997; entitled Sandra**  
6 **Teixeira v. City and County of San Francisco, et al.; the lawsuit involves an**  
7 **employment dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Sandra Teixeira v. City and County of  
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-23-609997 by the  
13 payment of \$162,500. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 October 26, 2023, and the following parties were named in the lawsuit: Plaintiff Sandra  
16 Teixeira, and defendant City and County of San Francisco.
