8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Taylor Wall v. City and County of San
11 Francisco, San Francisco Superior Court, Case No. CGC-24-618348 by the payment of
12 \$52,000. The lawsuit involves an employment dispute.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 September 23, 2024, and the following parties were named in the lawsuit: Taylor Wall, City
15 and County of San Francisco.
