They drift onto the surface of water and mimic the appearance of jellyfish and other floating organisms that are a natural food source for turtles, fish, dolphins, and shorebirds. The ingestion of balloons can choke, smother and entangle animals or cause animals to starve to death. In 1999, approximately 30 percent of the 32,028 balloons that were collected during U.S. coastal cleanup were found in California. This is a serious issue which has already been addressed by many groups. For example, the National Park Service has called for a national ban on the releasing of balloons within designated National Parks; the White House and the U.S. Navy have voluntarily suspended mass balloon launch activities; the San Francisco Parks and Recreation Department has stopped all mass balloon releases associated with their parks and recreation facilities; even Walt Disney World and Six Flags Great Adventure have discontinued mass balloon releases.*
