(c) Fee waiver. The fees set forth in Public Works Code Section 184.78 shall be 21 22 waived for Abraham Lincoln High School for up to twenty-five banners posted on City-owned

Section 2. Effective Date and Retroactivity. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance. However, the provisions of this ordinance shall be retroactive to September 1, 2015 if the effective date of the ordinance occurs after that date. If this ordinance becomes effective after September 1. 2015, the Board of Supervisors intends that the Department of Public Works exercise administrative discretion to waive the fee during that period. Otherwise, in light of the retroactivity provision above, upon the effective date of this ordinance, the Department of Public Works shall be obligated to refund any excess fees collected during that time period.
