14 the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that  
15 the issuance of a Type 21 off-sale general alcoholic beverage control license, to Linda Richard for  
16 Lucky/Albertson's Store No. 139, located at 3132 Clement Avenue will serve the public convenience and necessity  
17 of the people of the City and County of San Francisco.

18 Condition: Sales and service of alcoholic beverages shall be permitted only between the hours of 6:00 a.m.  
19 and 11:00 p.m. each day of the week.
