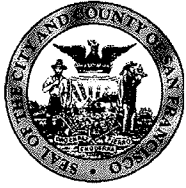

18 International Brotherhood of Electrical Workers, Local 6, to be effective July 1, 2024 through
19 June 30, 2027.


