10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Nikolas P. Lemos v. City and County
12 of San Francisco, San Francisco Superior Court, Case No. CGC 17-557100 by the payment
13 of \$100,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 February 16, 2017, and the following parties were named in the lawsuit: Plaintiff Nikolas P.
16 Lemos; Defendant City and County of San Francisco.






