4 **general eating place liquor license to Takehiko Yasuda for dba Lime Light at 1581**  
5 **Webster Street, #240 (District 5) in exchange of the current Type 48 on-sale**  
6 **general public premises license, and determining that it will not serve the public**  
7 **convenience and necessity of the people of the City and County of San**  
8 **Francisco, in accordance with section 23958.4 of the California Business and**  
9 **Professions Code.**

11 WHEREAS, Takehiko Yasuda is seeking the issuance of a Type 47 on-sale  
12 general eating place liquor license in exchange of the current Type 48 on-sale general  
13 public premises license for dba Lime Light at 1581 Webster Street, #240 (District 5);

15 WHEREAS, The Police Department reports that (1) the applicant premise is  
16 located in a "high crime" area and (2) the applicant premise is located in an "undue  
17 concentration" area; and

18 WHEREAS, The Police Department recommends that the liquor license  
19 application be denied; now, therefore, be it

20 RESOLVED, That in accordance with Section 23958.4 of the California Business  
21 and Professions Code, the Board of Supervisors of the City and County of San  
22 Francisco hereby determines that the issuance of a Type 47 on-sale general eating  
23 place liquor license in exchange of the current Type 48 on-sale general public premises  
24 license for dba Lime Light at 1581 Webster Street, #240 (District 5) requested by  
25 Takehiko Yasuda be denied.

1            FURTHER RESOLVED, That the Board of Supervisors respectfully requests that  
2 the Department of Alcoholic Beverage Control deny this application.


