Pursuant to Section 9.118 of the City Charter, I am forwarding, for the Board of Supervisors’ approval, Modification No. 1 to 2011 Lease and Use Agreement No. L10-0076 with Air France and Modification No. 2 to 2011 Lease and use Agreement No. L10-0081 with Cathay Pacific Airways Limited (“Cathay Pacific”) and the City and County of San Francisco, acting by and through its Airport Commission.


Modification No. 1 to L10-0076 approves a net gain of approximately 2,758 square feet of Exclusive Category II Space to Air France’s demised premises. Modification No. 2 to L10-0081 adds approximately 3,790 square feet of Exclusive Category II Space to Cathay Pacific’s demised premises. These Modifications will commence on the first day of the month following full City approval.
