3 **Ordinance authorizing settlement of the lawsuit filed by Roy Korobi against the City**
4 **and County of San Francisco for \$75,000; the lawsuit was filed on September 26, 2014,**
5 **in San Francisco Superior Court, Case No. CGC-14-541881; entitled Roy Korobi v. City**
6 **and County of San Francisco, et al.; the lawsuit involves alleged personal injury on a**
7 **City sidewalk; other material terms of the settlement are Co-Defendant Impark Pacific**
8 **Parking, LLC will pay plaintiff \$75,000.**

10 Be it ordained by the People of the City and County of San Francisco:


11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Roy Korobi v. City and County of San
13 Francisco, et al., San Francisco Superior Court, Case No. CGC-14-541881 by the payment of
14 \$75,000 and Co-Defendant Impark Pacific Parking, LLC will pay plaintiff \$75,000. The lawsuit
15 involves personal injury on a City sidewalk.

16 Section 2. The above-named action was filed in San Francisco Superior Court on
17 September 26, 2014, and the following parties were named in the lawsuit: Plaintiff Roy Korobi
18 and Defendants City and County of San Francisco and Impark Pacific Parking, LLC.






