Resolution authorizing the District Attorney of the City and County of San Francisco to retroactively accept and expend funds made available through The Office of Criminal Justice Planning for a project entitled "Elder Abuse Vertical Prosecution" and waiving indirect costs due to funding constraints.

WHEREAS, The City and County of San Francisco desires to continue a certain project designated the San Francisco District Attorney's Office Elder Abuse Vertical Prosecution Program with funding made available through the California Office of Criminal Justice Planning (hereafter "OCJP"); now, therefore, be it

RESOLVED, That the District Attorney of the City and County of San Francisco is authorized retroactively to accept and expend funds for Elder Abuse Vertical Prosecution purposes from OCJP; and, be it

FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of the City and County of San Francisco the necessary Grant Award Agreements for Elder Abuse Vertical Prosecution purposes including any extensions, augmentations or amendments thereof; and, be it

FURTHER RESOLVED, That indirect costs are waived due to funding constraints; and, be it

AGREED, That there are no matching funds required for said project under the Elder Abuse Vertical Prosecution Program and the rules and regulations of OCJP; and, be it

AGREED, That any liability arising out of the performance of the Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant
