

1 [Street Encroachment - Operator Convenience Facilities - Terminus of Various Muni Bus
2 Routes]

3 **Resolution granting revocable permission to the Municipal Transportation Agency to**
4 **occupy portions of the public right-of-way to install and maintain two new operator**
5 **convenience facilities at the terminus of various Muni bus routes; and making**
6 **environmental findings, and findings of consistency with the General Plan, and the**
7 **eight priority policies of Planning Code, Section 101.1.**

9 WHEREAS, Pursuant to Public Works Code Section 786, the San Francisco Municipal
10 Transportation Agency (SFMTA) requested permission to occupy portions of the public right-
11 of-way to install and maintain up to a total of seventy (70) operator convenience facilities
12 (restrooms) at the terminus of various Muni bus routes throughout the City. Copies of such
13 plans are on file in the office of the Clerk of the Board of Supervisors in File No. 131232 and
14 are incorporated herein by reference; and,

15 WHEREAS, The Transportation Advisory Staff Committee, at its meeting of December
16 20, 2012, recommended the proposed encroachments for approval; and,

17 WHEREAS, The Planning Department, by letter dated October 19, 2012, found 34 of
18 the proposed restroom locations to be in conformity with the General Plan, including the
19 following 2 specific locations: (1) Within an existing traffic island on Third Street at Keith
20 Street; and, (2) On the southerly sidewalk of Hudson Avenue, easterly of Third Street. This
21 letter also included a determination pursuant to the California Environmental Quality Act
22 (California Public Resources Code section 21000 et seq.). A copy of said letter is on file with
23 the Clerk of the Board of Supervisors in File No. 131232, and is incorporated herein by
24 reference; and,

1 WHEREAS, On July 16, 2012, the San Francisco Arts Commission adopted Resolution
2 No. 0910-12-227, which approved Phase 1 of the prefabricated design for 34 proposed
3 restroom locations. A copy of said Resolution is on file with the Clerk of the Board of
4 Supervisors in File No. 131232, and is incorporated herein by reference; and,

5 WHEREAS, After a duly noticed public hearing on May 22, 2012, the Department of
6 Public Works (DPW), in DPW Order No. 181381, dated June 13, 2013, recommended
7 approval of the proposed encroachments. A copy of said Order is on file with the Clerk of the
8 Board of Supervisors in File No. 131232, and is incorporated herein by reference; and,

9 WHEREAS, The permit and its associated encroachment agreement, which describes
10 the approximate locations of the restrooms among other terms, shall not become effective
11 until:

12 (a) The Permittee executes and acknowledges the permit and delivers said permit to
13 the City's Controller, and

14 (b) DPW records the permit and associated agreement in the office of the County
15 Recorder; and,

16 WHEREAS, The permit and its associated agreement are on file with the Clerk of the
17 Board of Supervisors in File No. 131232 and incorporated herein by reference; and,

18 WHEREAS, The Permittee, at its sole expense and as is necessary as a result of this
19 permit, shall make the following arrangements:

20 (a) To provide for the support and protection of facilities under the jurisdiction of DPW,
21 the San Francisco Water Department, the San Francisco Fire Department and other City
22 Departments, and public utility companies;

23 (b) To provide access to such facilities to allow said entities to construct, reconstruct,
24 maintain, operate, or repair such facilities; and,

1 (c) To remove or relocate such facilities if installation of the encroachment requires
2 said removal or relocation and to make all necessary arrangements with the owners of such
3 facilities, including payment for all their costs, should said removal or relocation be required;
4 and

5 WHEREAS, The Permittee shall procure the necessary permits for installation of the
6 restrooms from the Bureau of Street-Use and Mapping, Department of Public Works; and,


7 WHEREAS, No structures shall be erected or constructed within said street right-of-
8 way except as specifically permitted herein; and,

9 WHEREAS, The Permittee shall assume all costs for the maintenance and repair of the
10 encroachments and no cost or obligation of any kind shall accrue to DPW by reason of this
11 permission granted; now, therefore be it

12 RESOLVED, That pursuant to Public Works Code Section 786, the Board of
13 Supervisors hereby grants revocable permission to SFMTA, to occupy portions of the public
14 right-of-way to install and maintain two operator convenience facilities(1) Within an existing
15 traffic island on Third Street at Keith Street; and, (2) On the southerly sidewalk of Hudson
16 Avenue, easterly of Third Street. and, be it

17 FURTHER RESOLVED, That the Board adopts as its own the findings of consistency
18 with the General Plan and Planning Code Section 101.1 as set forth in the Planning
19 Department letter dated October 19, 2012, and affirms the environmental determination
20 contained in said letter.


