3 **Resolution determining that the transfer of a Type-21 off-sale general beer, wine,**
4 **and distilled spirits liquor license to Ayob's Community Market Corp., doing**
5 **business as Evergreen Market, located at 3250 Mission Street (District 9), will**
6 **serve the public convenience or necessity of the City and County of San**
7 **Francisco, in accordance with California Business and Professions Code,**
8 **Section 23958.4; and requesting that the California Department of Alcoholic**
9 **Beverage Control impose conditions on the issuance of the license.**

11 WHEREAS, Ayob's Community Market Corp, is seeking the transfer of a Type-21
12 off-sale general beer, wine, and distilled spirits liquor license to do business as
13 Evergreen Market, located at 3250 Mission Street (District 9); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed 55 protests and 19 letters of
17 support with the Department of Alcoholic Beverage Control under California Business
18 and Professions Code, Section 24013, and recommends that the Department of
19 Alcoholic Beverage Control issue the liquor license with conditions; and

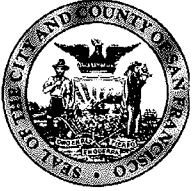
20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort
22 to prevent the loitering of persons on any property adjacent to the licensed premises as
23 depicted on the ABC-253; 2) The petitioner(s) shall be responsible for maintaining free
24 of litter the area adjacent to the premises over which they have control, as depicted on

1 ABC-253; and 3) Sales, service and of alcoholic beverages shall be permitted between
2 the hours of 08:00 am and 8:00 pm daily.; now, therefore, be it

3 RESOLVED, That in accordance with California Business and Professions Code,
4 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
5 hereby determines that the transfer of a Type-21 off-sale general beer, wine, and
6 distilled spirits liquor license to Ayob's Community Market Corp, doing business as
7 Evergreen Market, located at 3250 Mission Street, will serve the public convenience or
8 necessity of the City and County of San Francisco; and, be it

9 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
10 San Francisco hereby endorses and adopts the recommendations of the Police
11 Department listed above and recommends that the Department of Alcoholic Beverage
12 Control issue the license with those conditions.
