2 AUTHORIZING THE SHERIFF'S DEPARTMENT, ADULT PROBATION DEPARTMENT
3 AND JUVENILE PROBATION DEPARTMENT OF THE CITY AND COUNTY OF SAN
4 FRANCISCO TO APPLY FOR, ACCEPT AND EXPEND \$ 523,000.00 IN FUNDS FROM
5 THE STATE OF CALIFORNIA BOARD OF CORRECTIONS FOR THE STANDARDS AND
6 TRAINING OF LOCAL CORRECTIONS AND PROBATION OFFICERS PROGRAMS;
7 STIPULATING ADHERENCE TO STANDARDS FOR RECRUITMENT AND TRAINING
8 ESTABLISHED BY THE BOARD OF CORRECTIONS, WAIVING ANY INDIRECT COSTS.

11 WHEREAS, The Board of Corrections, State of California, may consent to review for
12 possible funding from funds made available through Senate Bill 924 (Part 3, Title 7, Chapter 5,
13 commencing with Section 6035 of the California Penal Code) the project submitted by the City
14 and County of San Francisco and referred to as the "Standards and Training of Local Corrections
15 Program." and

17 WHEREAS, the terms of the legislation establishing the program do not allow indirect or
18 administrative costs; therefore, be it

19 RESOLVED, that the Sheriff's Department, Adult Probation Department and Juvenile
20 Probation Department are hereby directed to submit to the Board of Corrections an application
21 for and accept \$523,000.00 for criminal justice purposes; and be it


23 FURTHER RESOLVED that the funds received hereunder shall be used to reimburse
24 training expenditures not reimbursed by the Peace Officers Standards and Training Program;

1 FURTHER RESOLVED that the City and County of San Francisco, while receiving aid
2 under terms of the Standards and Training of Local Corrections Programs will adhere to the
3 standards for recruitment and training established by the Board of Corrections, provided,
4 however, that the costs of such compliance are fully reimbursed or reimbursable by the State of
5 California and no additional costs will be incurred by the City and County of San Francisco; and,


8 FURTHER RESOLVED, that the Board of Supervisors does hereby waive indirect costs;


