

1 [Agreement - SFO Shuttle Bus Company - Shuttle Bus Services - Not to Exceed
2 \$105,000,000]

3 **Resolution approving the agreement between SFO Shuttle Bus Company and the City**
4 **and County of San Francisco to provide shuttle bus services at San Francisco**
5 **International Airport acting by and through its Airport Commission not to exceed**
6 **\$105,000,000 for a term of December 1, 2012, through June 30, 2016, plus three options**
7 **for two years each.**

9 WHEREAS, The City and County of San Francisco, acting by and through its Airport
10 Commission ("City"), wishes to continue to provide scheduled shuttle bus service at San
11 Francisco International Airport for air passengers and Airport employees, serving the terminal
12 complex, long-term parking lots, and other locations; and

13 WHEREAS, the current contract with SFO Shuttle Bus Company will expire on
14 November 30, 2012; and

15 WHEREAS, the City authorized staff, per Resolution No. 11-0174, to issue a Request
16 for Proposal (RFP) which was issued on June 5, 2012, and proposals were due August 10,
17 2012; and

18 WHEREAS, Airport staff and SFO Shuttle Bus Company have negotiated a new
19 Professional Services Agreement ("Agreement") to continue SFO Shuttle Bus Company's
20 management of the shuttle bus operation from December 1, 2012, through June 30, 2016,
21 plus three options for two years each; and

22 WHEREAS, based on scores for written proposals, the proposers' financial liquidity, as
23 measured by the Airport's Risk Manager, and oral interviews, the panel selected SFO Shuttle
24 Bus Company as the recommended contractor; and

1 WHEREAS, On November 9, 2012, by Resolution No. 12-0220, the Airport
2 Commission approved the Agreement, a copy of said Agreement being on file with the Clerk
3 of the Board of Supervisors in File No. 121032, which is hereby declared to be a part of this
4 resolution as if set forth fully herein; now, therefore, be it

5 RESOLVED, That this Board of Supervisors hereby approves the contract to provide
6 shuttle bus services at San Francisco International Airport Agreement between SFO Shuttle
7 Bus Company and the City and County of San Francisco, acting by and through its Airport
8 Commission for a not to exceed amount of \$105,000,000 for the agreement's total period of
9 from December 1, 2012, through June 30, 2016, plus three options for two years.
