There shall be no consumer price index or other base rent escalations permitted during the term; and, be it

FURTHER RESOLVED, That, except as expressly amended as provided herein, the Lease shall continue unmodified and remain in full force and effect including the indemnity provision that City shall hold Landlord harmless from any claims or liability for any injury or damage to any person or property occurring in or about the lease premises resulting from the negligence of City, its agents or employees, and, be it
