Ordinance authorizing settlement of the lawsuit filed by Floridalma Jeronimo and Gerardo Perez against the City and County of San Francisco for \$125,000; the lawsuit was filed on May 14, 2021, in San Francisco Superior Court, Case No. CGC-21-591939; entitled Floralidma Jeronimo, et al. v. City and County of San Francisco, et al.; the lawsuit involves alleged personal injury and wrongful death from medical negligence.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Floralidma Jeronimo, et al. v. City and County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-591939 by the payment of \$125,000. The lawsuit involves alleged personal injury and wrongful death from medical negligence.

Section 2. The above-named action was filed in San Francisco Superior Court on May 14, 2021, and the following parties were named in the lawsuit: Plaintiffs: Floridalma Jeronimo, Gerardo Perez, Defendants: CCSF, The Regents of the University of California, Carmen Rivera, CNM, Emily Beck, CNM, Arthurine Kulubo, MD, Malini A. Nijagal, MD.
