WHEREAS, The San Francisco Youth Commission has dedicated April 12th as Youth Gun Lobby Day; and,

WHEREAS, Members of the San Francisco Youth Commission and members of the youth community throughout the state will be in Sacramento to lobby their state legislators in favor of stricter gun control laws; now, therefore, be it
