16 Committee meetings or other important public business, and without causing difficulties in
17 achieving a quorum; and

18 WHEREAS, The Board of Supervisors establishes that it shall not meet during the
19 week after Thanksgiving, or between December 24 and 31, inclusive; and

20 WHEREAS, In 2008, the December 2, 2008 regularly scheduled meeting of the Board
21 of Supervisors falls in the week after Thanksgiving, and the December 30, 2008 regularly
22 scheduled meeting of the Board of Supervisors falls between December 24 and December
23 31, 2008; and
