

1 [Contract Amendment - Motorola Solutions, Inc. - Computer Aided Dispatch System and  
2 Mobile Computing System - Not to Exceed \$44,845,036]

3 **Resolution approving an amendment to the Agreement between the City and County of**  
4 **San Francisco and Motorola Solutions, Inc., for a computer aided dispatch and mobile**  
5 **computing system, to increase the amount by \$35,159,320 for a total not to exceed**  
6 **amount of \$44,845,036 and extend the term by eleven years from December 1, 2027, for**  
7 **a total contract term of December 22, 2023, through November 30, 2038.**

9 WHEREAS, On December 22, 2023, the City and County of San Francisco, acting  
10 through its Department of Emergency Management, entered into an agreement with Motorola  
11 Solutions, Inc., for the procurement of a Computer Aided Dispatch ("CAD") and Mobile  
12 Computing ("Mobile") System, associated interfaces and implementation, and project  
13 management to provide 9-1-1 dispatching services for the City ("Original Agreement"); and

14 WHEREAS, The Original Agreement was awarded to Contractor based on a  
15 competitive solicitation pursuant to Sourcing Event ID 0000006285; and

16 WHEREAS, The Original Agreement has a term of December 22, 2023, through  
17 November 30, 2027, for an amount not to exceed \$9,685,716; and

18 WHEREAS, The Original Agreement is on file with the Clerk of the Board of  
19 Supervisors in File No. 240127, which is hereby declared to be a part of this Resolution as if  
20 set forth fully herein; and

21 WHEREAS, The City wishes to amend the Original Agreement to allow for the  
22 provision of maintenance, support services, and systems and service options by extending the  
23 term by eleven years to November 30, 2038, and by increasing the maximum expenditure by  
24 \$35,159,320 to a total not to exceed amount of \$44,845,036 (the "First Amendment"); and

1           WHEREAS, The First Amendment is consistent with the Civil Service Commission's  
2 approval obtained on November 20, 2023, under PSC No. 40708-23/24 in the amount of  
3 \$45,000,000 for the period commencing December 1, 2023, and ending November 30, 2038;  
4 and

5           WHEREAS, San Francisco Charter, Section 9.118, "Contract and Lease Limitations",  
6 Subsection (b) requires Board of Supervisors' approval by Resolution of any contract which,  
7 when entered into, extends over 10 years, and of any contract which, when entered into, costs  
8 the City \$10,000,000 or more; and

9           WHEREAS, The First Amendment is on file with the Clerk of the Board of Supervisors  
10 in File No. 240127, and available on the Board's website, substantially in final form, with all  
11 material terms and conditions included, and only remains to be executed by the parties upon  
12 approval of this Resolution; and

13           WHEREAS, The First Amendment is hereby declared to be a part of this Resolution as  
14 if set forth fully herein; now, therefore, be it

15           RESOLVED, That the Board of Supervisors hereby approves the First Amendment of  
16 the CAD and Mobile System Agreement by and between Motorola Solutions, Inc., and the  
17 City and County of San Francisco, acting by and through its Department of Emergency  
18 Management; and, be it

19           FURTHER RESOLVED, That within thirty (30) days of the First Amendment being fully  
20 executed by all parties, the Department of Emergency Management shall submit to the Clerk  
21 of the Board of Supervisors a completely executed copy for inclusion in File No. 240127; this  
22 requirement and obligation resides with the Department of Emergency Management, and is  
23 for purposes of having a complete file only, and in no manner affects the validity of the  
24 approved contract.


