3 **Resolution appointing Susuan Garbuio, term ending September 30, 2003, and Rose Lou**  
4 **Randolph, Carole Kilgariff, and Darrick Lam, terms ending September 30, 2004, to the**  
5 **Adult Day Health Care Planning Council, residency requirement waived.**

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
8 does hereby appoint the hereinafter designated persons to serve as members of the Adult  
9 Day Health Care Planning Council, pursuant to the provisions in the Health and Safety Code,  
10 Section 1572.5, and the San Francisco Administrative Code, Section 44.3, for the term  
11 specified:

12 Rose Lou Randolph, succeeding herself, term expired, seat 2, must represent age  
13 group, for a new three-year term ending September 30, 2004;

14 Carole Kilgariff, succeeding herself, term expired, seat 3, must represent age group, for  
15 a new three-year term ending September 30, 2004;

16 Susuan Garbuio, succeeding Carole Kilgariff, term expired, seat 7, must represent age  
17 group, for a new three-year term ending September 30, 2003;

18 Darrick Lam (residency requirement waived), succeeding himself, term expired, seat  
19 10, must represent the Commission on the Aging, for a new three-year term ending  
20 September 30, 2004; and, be it

21 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 22 1. The membership of the Adult Day Health Care Planning Council has a goal to be  
23 representative of the diversity of the City and County of San Francisco.

- 1           2. Applicant Darrick Lam, a new appointee, who is not a resident of San Francisco, is  
2           a person with experience that uniquely qualifies him/her to serve on the Adult Day  
3           Health Care Planning Council.
- 4           3. The Adult Day Health Care Planning Council has attempted to fill the position, for  
5           which Darrick Lam was nominated, with an individual who is a City resident and  
6           who has the specific experience, skills, and qualifications, but has been unable to  
7           do so at this time. The Rules Committee has certified that Darrick Lam is qualified  
8           to serve on the Adult Day Health Care Planning Council.
- 9           4. After exercising due diligence, the Board of Supervisors concludes that there is no  
10          other possible representative, who is a resident of San Francisco and who has the  
11          specific experience, skills, or qualifications possessed by this applicant, and who is  
12          willing to serve on the Adult Day Health Care Planning Council at this time; and, be  
13          it

14           FURTHER RESOLVED, That the Board of Supervisors waives the residency  
15          requirement for Darrick Lam, as allowed in cases where no qualified City resident, willing to  
16          serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)  
17          appointed to boards, commissions, and advisory bodies established by legislative act of the  
18          Board of Supervisors to be resident(s) of the City and County of San Francisco.
