2 **AUTHORIZING THE CITY AND COUNTY OF SAN FRANCISCO TO ENTER AN**
3 **APPLICATION FOR THE 1999 CSAC CHALLENGE AWARDS COMPETITION FOR THE**
4 **SAN FRANCISCO CHILD CARE FACILITIES FUND (CCFF).**

5 WHEREAS, the California State Association of Counties (CSAC) is sponsoring the
6 CSAC Challenge Awards Program, which recognizes the innovative and creative spirit of
7 California county governments for finding new and effective ways of providing services to their
8 residents; and

9 WHEREAS, the Child Care Facilities Fund (CCFF) is an innovative partnership among
10 the City, the Miriam and Peter Haas Fund, Providian Financial Corporation, child care
11 providers, parents and many others dedicated to supporting working families in San
12 Francisco; and

13 WHEREAS, the mission of the CCFF is to expand the supply and improve the quality of
14 child care available to low income families by offering grants, loans and technical assistance
15 to family child care providers and child care centers located in San Francisco to make capital
16 improvements; and

17 WHEREAS, San Francisco families -- especially those affected by welfare reform --
18 need access to high quality child care in order to go to work and in order for their children to
19 be safe and to flourish; and

20 WHEREAS, the CCFF is administered by the Low Income Housing Fund (CCFF), a
21 national nonprofit leader in lending to community facilities who recently received the local
22 "Partners in Community Development Award" as part of the Community Development Block
23 Grant 25th anniversary celebration for their participation in this partnership; and

24 WHEREAS, since its inception in January 1998, the CCFF has created more than three
25 hundred new child care slots and has improved the quality of care for thousands of children;
and

1 WHEREAS, in the long term, through its programs, the CCFF will help more than
2 sixteen hundred families transition from welfare to work, create more than three thousand new
3 child care slots, and increase the fiscal health and stability of the child care sector; and

4 WHEREAS, the CCFF is an excellent example of a creative, county-level partnership
5 that is generating new revenues and coordinating existing resources to improve services to
6 families; and

7 WHEREAS, the City and County of San Francisco desires to participate in the 1999
8 Challenge Awards Program and agrees to the program's requirements and responsibilities as
9 set forth by CSAC for entering the awards program, including submitting the application by
10 June 25, 1999; now, therefore

11 BE IT RESOLVED, that the Board of Supervisors of the City and County of San
12 Francisco authorizes the President of the Board of Supervisors or his designee to submit an
13 application to CSAC for the Challenge Awards competition for the Child Care Facilities Fund
14 (CCFF).




