1 [Board Response to the 2010-2011 Civil Grand Jury Report Entitled "Hiring Practices of the
2 City and County of San Francisco"]

3 **Resolution responding to the Presiding Judge of the Superior Court on the findings**
4 **and recommendations contained in the 2010-2011 Civil Grand Jury Report entitled**
5 **"Hiring Practices of the City and County of San Francisco" and urging the Mayor to**
6 **cause the implementation of accepted findings and recommendations through his**
7 **department heads and through the development of the annual budget.**

9 WHEREAS, Under California Penal Code Section 933 et seq., the Board of
10 Supervisors must respond, within 90 days of receipt, to the Presiding Judge of the Superior
11 Court on the findings and recommendations contained in Civil Grand Jury Reports; and

12 WHEREAS, In accordance with Penal Code Section 933.05(c), if a finding or
13 recommendation of the Civil Grand Jury addresses budgetary or personnel matters of a
14 county agency or a department headed by an elected officer, the agency or department head
15 and the Board of Supervisors shall respond if requested by the Civil Grand Jury, but the
16 response of the Board of Supervisors shall address only budgetary or personnel matters over
17 which it has some decision making authority; and

18 WHEREAS, The 2010-2011 Civil Grand Jury Report entitled "Hiring Practices of the
19 City and County of San Francisco" is on file with the Clerk of the Board of Supervisors in File
20 No. 110790 which is hereby declared to be a part of this resolution as if set forth fully herein;
21 and,

22 WHEREAS, The Civil Grand Jury has requested that the Board of Supervisors respond
23 to Finding No. V as well as Recommendation No. V contained in the subject Civil Grand Jury
24 report; and

1 WHEREAS, Finding No. V states: "As the hiring practice in the City becomes
2 increasingly decentralized and Position Based Testing becomes more prevalent, there is
3 growing doubt among some City workers that the Commission as currently staffed is able to
4 protect their rights;" and

5 WHEREAS, Recommendation No. V states: "The Commission should be authorized to
6 hire at least one additional senior personnel analyst;" and

7 WHEREAS, in accordance with Penal Code Section 933.05(c), the Board of
8 Supervisors must respond, within 90 days of receipt, to the Presiding Judge of the Superior
9 Court on Finding No. V, as well as Recommendation No. V contained in the subject Civil
10 Grand Jury report; now, therefore, be it

12 Superior Court that it _____{agrees/disagrees} with Finding No. V, for reasons as
