WHEREAS, Adding a seventh member to the Joint Zoo Committee would require that the parties to the agreement propose for Board approval an amendment to the Agreement; now, therefore, be it

RESOLVED, That the Board of Supervisors urges the San Francisco Zoological Society and the Recreation and Park Commission to propose to the Board of Supervisors an

amendment to the Zoo Lease and Management Agreement that would alter the composition of the Joint Zoo Committee by adding the Director of the Animal Care and Control Department as a seventh member.
