13	Section 1. Findings. The Board of Supervisors of the City and County of San Francisco
14	hereby finds and determines that:

16	ordinance will serve the public necessity, convenience and welfare for the reasons set forth in
17	Planning Commission Resolution Norecommending approval of these Planning
18	Code and Zoning Map Amendments, and incorporates such reasons by this reference thereto.

21	(b) Pursuant to Planning Code Section 101.1, this Board of Supervisors finds that this
