9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Administrative Code is hereby amended by adding  
11 Section 1.59, to read as follows:

12 Sec. 1.59. TRANSFER OF INSTITUTIONAL POLICE DEPARTMENT

13 The Director of the Department of Public Health and the Sheriff are authorized to enter into an  
14 interagency agreement to transfer the Institutional Police Department from the Department of Public  
15 Health to the Sheriff consistent with the management agreement contained on file with the Clerk of the  
16 Board of Supervisors in File No. 021997. The Controller and the Director of the Department of  
17 Human Resources are authorized to take all steps necessary to effectuate the transfer authorized by this  
18 Section, including, but not limited to, the transfer of funds and personnel.


