Ordinance authorizing settlement of the lawsuit filed by Encompass Insurance
Company against the City and County of San Francisco for \$1,250,000; the lawsuit was
filed on April 2, 2014, in San Francisco Superior Court, Case No. CGC-14-538395;
entitled Encompass Insurance Company v. City and County of San Francisco, et al.; the
lawsuit involves alleged property damage arising from the break of the Public Utilities
Commission's water transmission pipeline on 15th Avenue between West Portal
Avenue and Wawona Street in San Francisco; and appropriating \$1,250,000 from the
Water Enterprise fund balance for such purpose.
