Ordinance authorizing settlement of the portion of the lawsuit filed by James Cordova/Maria Morales against the City and County of San Francisco for \$35,000; the lawsuit was filed on January 31, 2005 in San Francisco Superior Court, Case No. 436930; entitled Jane Martin, et al. v. City and County of San Francisco, et al.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The City Attorney is hereby authorized to settle the portion of the action entitled "Jane Martin, et al. v. City and County of San Francisco, et al.," San Francisco Superior Court, Court No. 436930, as it relates only to co-plaintiffs James Cordova/Maria Morales, by the payment of \$35,000, and excluding the claim by these plaintiffs for diminution of property value, attorney's fees, costs and interest, which will be addressed in later proceedings.

Section 2. The above-named action was filed in San Francisco Superior Court on January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiffs James Cordova/Maria Morales and Defendant City and County of San Francisco.
