17 Board of Supervisors may plan to be away from the Board without missing any Board or  
18 Committee meetings or other important public business, and without causing difficulties in  
19 achieving a quorum, the Board of Supervisors now wishes to follow the tradition established  
20 by many other sitting legislative bodies in the United States and provide for scheduled recess  
21 period, and selects the period from August 16, through September 5, 2006 for this recess;  
22 now, therefore, be it,


