Resolution designating certain intersections as "STOP" intersections.

RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the following intersections are hereby designated as "STOP" intersections, and the Department of Parking and Traffic is hereby authorized and directed to cause "STOP" signs to be installed thereat as designated below:

STOP SIGNS - ESTABLISH

Park Hill at Roosevelt Way, stopping Park Hill;

Laguna and Waller Streets, stopping Waller Street;

- Second Street extension at King Street, stopping the northbound leg of Second Street at King Street;
- 26th and Hampshire Streets, stopping eastbound 26th Street, making this intersection a one-way STOP;
- McKinnon Avenue and Lane Street, stopping eastbound McKinnon Avenue and northbound and southbound Lane Street, making this intersection an All-Way STOP;
- 22nd and Mississippi Streets, stopping southbound Mississippi Street; and,
- 19th and Pennsylvania Streets, stopping Pennsylvania at 19th Street, making this an All-Way STOP.

Categorically exempt from Environmental Review Class 1(c)(9) changes in the traffic and parking regulations where such changes do not establish a higher speed limit or result in more than a negligible increase in the use of the street.
