- > One (1) member shall be an older adult advocate (a family member or Consumer advocate for persons 60 years of age or older who use mental health services); and
- > Two (2) members shall be from the following professions: psychiatry, psychology, mental health social work, nursing with a specialty in mental health, marriage and family counseling,

psychiatric technology, or administrator of a hospital providing mental health services or of a community mental health facility.

NOTE: A "Consumer" is a person who has received mental health services in San Francisco from any program operated or funded by the City and County, from a State hospital, or from any public or private nonprofit mental health agency. The Board of Supervisors member position shall not count in determining whether the Consumer and family of Consumer requirements of this section are met.

Any positions not allocated to specific types of members may be filled by persons with experience and knowledge of the mental health system representing the public interest.

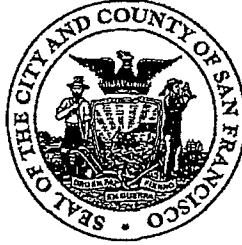
Except for the Board of Supervisors member, the term of each member shall be for three years. No member shall serve more than two consecutive terms. The term of office of a member appointed by an individual Board of Supervisors member is not affected by the Board of Supervisors member no longer continuing in that office.

The Mental Health Board shall review and evaluate the City and County's mental health needs, services, facilities and special problems and other duties as stated in Administrative Code, Section 15.14:

"Family Member of a Consumer" includes domestic partners and significant others.

"Mental Health Professional" shall be from the following professions: psychiatry, psychology, mental health social work, nursing with a specialty in mental health, marriage and family counseling, psychiatric technology, or administrator of a hospital providing mental health services or of a community health facility.

Exclusions: No member or his/her spouse shall be a full-time or part-time County employee of a County mental health service, an employee of the State Department of Mental Health, or an employee of, or a paid member of the governing body of, a Bronzan-McCorquodale contract agency.

Reports: An annual report on the needs and performance of the City and County's mental health system shall be submitted to the Board of Supervisors.

Business and/or professional experience:



Enclosed please find my Resume and Letter of Recommendation for the Family Member Seat on the Mental Health Board.



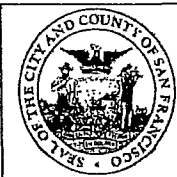

I am the current vice chair of the MHB of San Francisco. In addition I have a Masters in Counseling. I am also a licensed Marriage Family Therapist (MFT) and school counselor (PPSC) in the state of California. My qualifications have allowed me to work closely with my San Francisco community by providing mental health services. My prior experience (from 2006 - August 2014) at Richmond Area Multi-Services (RAMS), a community mental health agency in San Francisco have allowed me to provide school

based-services in the San Francisco Unified School District and outpatient setting. I worked at Galileo High School, serving a diverse population in terms of its ethnicity, race, sex and socioeconomic status. I provided school-based mental health services with the Wellness Program. My services included crisis work, individual and group counseling, parent work, trainings, consultation and working with teachers and staff. In addition, I also worked at outpatient RAMS clinic providing counseling to adults, working with emotionally disturbed children and trainings to staff.

Currently I teach full-time at local graduate Counseling and Psychology programs in the San Francisco bay area.

Business and/or Professional experience:

As highlighted in the above box, I have extensive experience of providing direct counseling services in community mental health and school-based services in San Francisco. My experience has allowed me to understand the needs of the San Francisco community, ways I can support, and advocate for their needs. Currently, I teach in local graduate counseling and psychology programs. I am using my direct experience of counseling to teach and train students-in-training. I am full-time core faculty at The Wright Institute, Berkeley where I teach Counseling Psychology graduate classes and supervise students. At the Wright Institute, we believe in social justice and providing community mental health services. I am also adjunct faculty at San Francisco State University, Masters in Counseling Program where I teach a variety of graduate counseling courses. In addition, I have a modest private practice and see children and adults, provide trainings and take pro-bono and sliding scale clients. My goal in private practice is to provide supportive services to diverse community members. Through my trainings in the community, I help to reduce mental health stigma and provide awareness on counseling topics.

Written Testimony for the Reappointment of Seat #15, MHB of San Francisco from Ms. Ulash Thakore-Dunlap

Dear Rules Committee Members: Supervisors Malia Cohen, Eric Mar, and Katy Tang,

I am sorry that I am unable to attend in person. Today I would have loved the opportunity to present to you the many reasons for wanting to continue to serve on the Mental Health Board (MHB) of San Francisco. Today, I am working and unable to reschedule my work meetings. Currently I am full-time professor at The Wright Institute in the MA Counseling Psychology Program, lecturer at San Francisco State University in the MS Counseling Program, and maintain a private practice in San Francisco.

I have been serving on the MHB of San Francisco since my first appointment in November 2014. I am also the current Vice Chair of the board. I feel the board is very active in engaging the public and listening to their needs, educating, and working on ways to improve access to behavioral health services. The board is working tirelessly to start dialogues with the public to understand the barriers to treatment and ways to address their needs. Last year we passed many resolutions, such as urging the Board of Supervisors and the Mayor to provide funding for the San Francisco Police Department Crisis Intervention Team, and the San Francisco Sheriff's Department to fund crisis intervention training for which includes accountability and program evaluation. In addition, the board worked successfully on the following goals set in 2014-15: to explore information and access to behavioral services, chronic trauma related to youth and family issues, and issues concerning incarcerated individuals with a mental illness.

I hope to continue to be on the board and carry out our set goals for 2015-16 which include: identifying barriers to behavioral health services, exploring the impact of community violence on mental health, and access to behavioral health services for those that are homeless. Currently I am co-chairing the impact of community violence committee. I really enjoy the energy and collegial aspect of the board, and I am always learning from them. I feel so honored to be able to work with the board, staff members Helynna and Loy, the public, and others to meet our board goals.

In terms of the future direction of the board, I hope as a team we can continue to encourage a diverse pool of candidates to fill the MHB positions (e.g. age, socioeconomic, race and sexual orientation.) My hope is we can collaborate more with the Board of Supervisors on ways to better serve the mental health needs of our SF community. In addition I hope we can work with other boards/commissions in SF, such as the Health Commission in exploring ways we can work together through advocacy and presentations on wellness and wellbeing.

I thank you for taking the time in reading my testimony.


