13 a minimum of five years professional experience in the State of California as one of the  
14 following: certified public accountant (CPA) or public accountant (PA); licensed real estate  
15 broker; attorney; or a property appraiser accredited by a nationally recognized professional  
16 organization, or property appraiser certified by the Office of Real Estate Appraisers; or he or  
17 she is a current member of an assessment appeals board, for the unexpired portion of a  
18 three-year term ending September 1, 2008.

19 Stephen Wasserman, succeeding Carol Ruth Silver, resigned, seat 7  
20 (ALTERNATE/HEARING OFFICER), must meet the eligibility criteria set forth in Section  
21 1624.05 of the California Revenue and Taxation Code: Must have a minimum of five years  
22 professional experience in the State of California as one of the following: certified public  
23 accountant (CPA) or public accountant (PA); licensed real estate broker; attorney; or a  
24 property appraiser accredited by a nationally recognized professional organization, or property  
25 appraiser certified by the Office of Real Estate Appraisers; or he or she is a current member of

1 an assessment appeals board, for the unexpired portion of a three-year term ending  
2 September 1, 2008.
