[Settlement of Lawsuit - Cal State Constructors, Inc. - \$500,000]

Ordinance authorizing settlement of the lawsuit filed by Cal State Constructors, Inc. ("Cal State") against the City and County of San Francisco for \$500,000; the lawsuit was filed on November 25, 2014, in the Superior Court of California, County of San Francisco, Case No. CGC-14-542910; entitled Cal State Constructors, Inc. v. City and County of San Francisco; other material terms of said settlement are that the City reserves all rights to pursue claims against Cal State for, and Cal State shall retain responsibility for, latent defects; all extant express and implied warranties under the contract shall remain in full force and effect; Cal State will defend, indemnify, and hold the City harmless from all subcontractor claims; the City and Cal State will execute a mutual release; and the City and Cal State will each bear its own fees and costs.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Cal State Constructors</u>, <u>Inc. v. City and County of San Francisco</u>, Superior Court of California, County of San Francisco, Case No. CGC-14-542910 by the payment of \$500,000; the City's reservation of all rights to pursue claims against Cal State Constructors, Inc. ("Cal State") for, and Cal State's retention of responsibility for, latent defects; the continuation in full force and effect of all extant express and implied warranties under the contract; Cal State's agreement to defend, indemnify, and hold the City harmless from all subcontractor claims; the execution of a mutual release between the City and Cal State; and the City and Cal State each bearing its own fees and costs.
