3 **Ordinance authorizing settlement of the lawsuit filed by Cal State Constructors, Inc.**
4 **("Cal State") against the City and County of San Francisco for \$500,000; the lawsuit**
5 **was filed on November 25, 2014, in the Superior Court of California, County of San**
6 **Francisco, Case No. CGC-14-542910; entitled Cal State Constructors, Inc. v. City and**
7 **County of San Francisco; other material terms of said settlement are that the City**
8 **reserves all rights to pursue claims against Cal State for, and Cal State shall retain**
9 **responsibility for, latent defects; all extant express and implied warranties under the**
10 **contract shall remain in full force and effect; Cal State will defend, indemnify, and hold**
11 **the City harmless from all subcontractor claims; the City and Cal State will execute a**
12 **mutual release; and the City and Cal State will each bear its own fees and costs.**

14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
16 authorizes the City Attorney to settle the action entitled Cal State Constructors, Inc. v. City
17 and County of San Francisco, Superior Court of California, County of San Francisco, Case
18 No. CGC-14-542910 by the payment of \$500,000; the City's reservation of all rights to pursue
19 claims against Cal State Constructors, Inc. ("Cal State") for, and Cal State's retention of
20 responsibility for, latent defects; the continuation in full force and effect of all extant express
21 and implied warranties under the contract; Cal State's agreement to defend, indemnify, and
22 hold the City harmless from all subcontractor claims; the execution of a mutual release
23 between the City and Cal State; and the City and Cal State each bearing its own fees and
24 costs.




