8 WHEREAS, Glynn Washington has served for three years as the Administrator of the
9 San Francisco Human Services Network (HSN), an association of over ninety community-
10 based nonprofit organizations dedicated to addressing issues critical to the health and human
11 services sector and the City's most vulnerable residents; and,

13 WHEREAS, During Glynn Washington's tenure, HSN has coalesced as a major public
14 policy forum for health and human services providers in San Francisco, and has established a
15 proactive presence in the policy arena; and,

17 WHEREAS, Through Glynn Washington's participation, HSN provided a nonprofit
18 voice in the development of major City policy initiatives, including the Minimum Compensation
19 Ordinance, the Health Care Accountability Ordinance, and developing solutions to the City's
20 nonprofit office space crisis; and,

22 WHEREAS, Glynn Washington spearheaded the nonprofit effort that prompted the
23 City to establish a Nonprofit Contract Reform Task Force to save resources by streamlining
24 contracting and monitoring requirements; and,

26 WHEREAS, Glynn Washington has helped the nonprofit community play a significant
27 role in the City's annual budget process to advocate for crucial safety-net services; and,

1 WHEREAS, since 1999, HSN's membership of nonprofit organizations has more than
2 doubled; and,

3 WHEREAS, Glynn Washington's dedication, leadership and effectiveness have
4 enhanced the strength and ability of the human services community to serve children, youth,
5 disadvantaged adults, families, the poor and the sick; now therefore be it,

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 hereby commends Glynn Washington for the achievements of the San Francisco Human
8 Services Network and for his service to our City.




