3	Resolution enacting and rescinding parking regulations at various locations.

5	RESOLVED, That, in accordance with the provisions of the California
6	Vehicle Code and the San Francisco Traffic Code, the following regulations
7	governing the parking of vehicles are hereby enacted or rescinded as designated
8	below:
9	NO PARKING ANYTIME - RESCIND TOW-AWAY, NO PARKING ANYTIME - ESTABLISH
10	Russian Hill Place, east side, from Vallejo to 15 feet northerly.
11	TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH
12 13	Point Lobos Avenue, south side, from 40th Avenue to 80 feet westerly (adjacent to center roadway island).
14	TOW-AWAY, NO PARKING ANYTIME, 10 PM - 6 AM, EVERYDAY - ESTABLISH
15	Executive Park Boulevard, east side, between Alana Way and Blanken Avenue.
16	PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH
17	Ervine Street, west side, from Wilde Street to 346 feet southerly;
18	South Park Avenue, both sides, from 2nd Street to 125 feet westerly; and
19	South Park Avenue, both sides, from 3rd Street to 125 feet easterly.
20 21	TWO-HOUR PARKING TIME LIMIT, 9 AM - 5 PM, MONDAY THROUGH FRIDAY - ESTABLISH
22	18th Street, both sides, between 3rd and Tennessee Streets.
23	UNMETERED MOTORCYCLE PARKING - ESTABLISH
24	7th Street, west side, from 48 to 76 feet north of Townsend Street (accommodates six unmetered motorcycle parking spaces); and
25	UNMETERED MOTORCYCLE PARKING - ESTABLISH (cont'd)

1	8th Street, east side, from Division Street to 10.5 feet northerly (accommodates three unmetered motorcycle parking spaces).
2	
3	RESIDENTIAL PERMIT PARKING AREA "J" (2-HOUR TIME LIMIT, 8 AM - 5 PM, MONDAY THROUGH FRIDAY) - ESTABLISH
4	17th Street, both sides, between Shrader and Stanyan Streets (4900 block).
5	RESIDENTIAL PERMIT PARKING AREA "S" (2-HOUR TIME LIMIT, 8 AM - 9 PM, MONDAY THROUGH FRIDAY) - RESCIND
6	MONDAT THROUGH FRIDAT) - RESCIND
7	Rose Street, north side, from Market Street to 26 feet westerly.
8	RESIDENTIAL PERMIT PARKING AREA "X" (2-HOUR TIME LIMIT, 8 AM - 6 PM, MONDAY THROUGH FRIDAY) - ESTABLISH
9	Arkansas Street, east side, from 50 feet south of 17th Street to Marioposa Street
10	(100 block, starting with address #113); and
11	Arkansas Street, west side, between 17th and Mariposa Streets (100 block).
12	RESIDENTIAL PERMIT PARKING AREA "Z" (2-HOUR TIME LIMIT, 8 AM - 6 PM, MONDAY THROUGH FRIDAY) - ESTABLISH
13	25th Street, both sides, between Church and Dolores Streets (3800 block);
14 15	Church Street, both sides, between 25th and Clipper Streets. (portion of the 1300 block);
16	Fair Oaks Street, both sides, between 21st and 22nd Streets (Unit block); and
17	Valencia Street, east side, from 22nd to 23rd Streets (1100 block).
18	(Note: The meters will not be removed and Residential Permit Parking signs will not be installed on Valencia Street.)
19	
20	Categorically exempt from Environmental Review Class 1(c)(9) changes in the traffic
21	and parking regulations where such
22	changes do not establish a higher speed limit or result in more than a negligible
23	increase in the use of the street.
