1 [Agreement - ARAMARK Correctional Services, LLC - Not to Exceed \$19,659,606]

3 **Resolution authorizing the Sheriff's Department to retroactively enter into a**
4 **contract agreement between the City and County of San Francisco and**
5 **ARAMARK Correctional Services, LLC, for inmate meal services for a five year**
6 **term beginning July 1, 2012, with two one-year options exercisable by the**
7 **Sheriff's Department, for an amount not to exceed \$19,659,606.**

9 WHEREAS, Charter Section 9.118 (b) of the Charter of the City and County of
10 San Francisco requires that contracts or agreements entered into by a department,
11 board or commission requiring anticipated expenditures of ten million dollars, shall be
12 subject to approval of the Board of Supervisors by resolution; and,

13 WHEREAS, The Controller has certified that jail food services can practically
14 be performed by a private contractor at a lower cost than if work were performed by
15 city employees at budgeted levels pursuant to Charter Section 10.104.15; and,

17 WHEREAS, On February 27, 2012, the Sheriff's Department issued a
18 Request for Proposals for Food Service Operations at the County Jails and as a
19 result of that selections process, identified Aramark Correctional Services, LLC to
20 receive a contract in the amount of \$19,659,606 over five years to provide jail food
21 services; now, therefore, be it

23 **RESOLVED, That the Board of Supervisors hereby retroactively approves the**
24 **Inmate Meal Services Agreement by and between ARAMARK Correctional Services,**
25 **LLC. And the City and County of San Francisco, acting by and through its Sheriff's**

1 Department, for a five year term beginning July 1, 2012, with two one-year options
2 exercisable by the Sheriff's Department.
