3 **Resolution designating, on an interim basis, the Adult Probation Department as the**

9 WHEREAS, Title II of AB 109, the Post-Release Community Supervision Act of 2011,  
10 will take effect on October 1, 2011; and,

11 WHEREAS, the Post-Release Community Supervision Act of 2011 requires that each  
12 County Board of Supervisors designate a county agency responsible for implementing post-  
13 release community supervision; and,

14 WHEREAS, AB 117, which was enacted on June 30, 2011, requires that each such  
15 designated county agency notify the California Department of Corrections and Rehabilitation  
16 by August 1, 2011 of its designation as the agency responsible for implementing post-release  
17 community supervision, therefore, be it

18 **RESOLVED** That the Adult Probation Department is the San Francisco county agency  
19 designated as responsible for implementing post-release community supervision until an  
20 ordinance designating the Adult Probation Department as the county agency responsible for  
21 implementing post-release community supervision has been considered and adopted by the  
22 Board of Supervisors.
