9	Be it ordained	d by the People of the City and County of San Francisco:
10	Section 1. The	ne Municipal Elections Code is hereby amended by amending Section
11	500, to read as follo	ws:
12	SEC. 500. V	OTER INFORMATION PAMPHLET; CONTENTS; FORMAT.
13	With respect	to any election to be held in the City and County, the Director of Elections
14	shall prepare a vote	r information pamphlet. The voter information pamphlet shall contain, in
15	addition to any other	r material required by the Charter or by general law, the following
16	materials:	
17	(a) Genera	al contents:
18	(1)	A table of contents;
19	(2)	An index of candidates and measures;
20	(3)	A brief explanation of the purpose and use of the pamphlet;
21	(4)	A summary of voters' rights, including a description of the right provided to
22	every elector by Cal	ifornia Elections Code sections 9295 and 13314 to seek a writ of mandate
23	or an injunction prior to the publication of the Voter Information Pamphlet, requiring any or all	
24	of the materials submitted for publication in the Pamphlet to be amended or deleted;	

1	(5)	A brief description of the rules and procedures that govern the submission,
2	selection and pub	olication of ballot arguments in the pamphlet, including a statement explaining
3	that each person	entitled to submit a "Proponent's" or "Opponent's" argument is chosen
4	pursuant to the p	riority list stated in Section 545 of this Code;
5	(6)	A disclaimer that neither the Director of Elections nor any other City
6	agency, official or	employee verifies the accuracy of information contained in the ballot
7	arguments or car	didate qualification statements appearing in the pamphlet, and an
8	explanation that a	any person submitting a ballot argument or qualifications statement bears the
9	sole responsibility	for claims made therein;
10	(7)	Artwork, graphics and other material which the Director of Elections
11	determines will m	ake the pamphlet easier to understand or more useful to the voter;
12	(8)	Definitions of terms appearing in the pamphlet; and
13	(9)	A sample ballot.
14	(b) Con	tents as to candidates:
15	(1)	The candidate qualification statement of each candidate for City elective
16	office;	
17	(2)	A brief statement of the term, compensation, and duties of each City
18	elective office app	pearing in the pamphlet; and
19	(3)	Any notice required by the Campaign Finance Reform Ordinance or the
20	Political Reform A	Act, Government Code Section 85600, informing voters whether the
21	candidate has ad	opted the applicable voluntary expenditure ceiling.
22	(c) Con	tents as to measures:
23	(1)	The identification of each measure by letter and title;
24	(2)	The City Attorney's statement or question for each measure;

1	(3) The digest of each measure prepared by the Ballot Simplification
2	Committee;
3	(4) The Controller's financial analysis of each measure;
4	(5) An explanation of how the measure qualified for submission to the voters;
5	(A) If the measure was submitted to the voters by the Board of
6	Supervisors, the explanation required by Subsection (c)(5) of this Section shall identify those
7	Supervisors who voted for submission of the measure and those Supervisors who voted
8	against submission of the measure,
9	(B) If the measure was submitted to the voters by four or more
10	members of the Board of Supervisors, the explanation required by Subsection (c)(5) of this
11	Section shall identify those Supervisors who submitted the measure,
12	(C) If the measure was submitted to the voters by initiative petition, the
13	explanation required by Subsection (c)(5) of this Section shall include the number of valid
14	signatures of registered San Francisco voters that were required to qualify the measure for
15	the ballot, and the date on which the Director of Elections certified that the measure qualified
16	for the ballot;
17	(6) The full text of each measure to be voted upon at the election;
18	(76) The opponent, proponent, rebuttal and paid arguments, if any, for or
19	against each measure;-
20	(7) The full legal text of each Charter amendment to be voted upon at the
21	election. For each Charter amendment, the Department of Elections shall cause to be printed
22	immediately below the Ballot Simplification Committee digest, in no less than 10-point bold
23	type, a statement substantially as follows: "The above statement is an impartial analysis of
24	Measure . The full text of this measure appears at page (insert page number)."

(<u>8</u> 7) The full legal text of each measure other than a Charter amendment to be
voted upon at the election, unless the legal text of a the measure as submitted to the Department of
Elections exceeds 100 pages. In that event, the voter information pamphlet shall contain the first
20 pages of the legal text of the measure as submitted to the Department of Elections,
provided that the Board of Supervisors may adopt a resolution, effective no later than the 94th
day prior to the date of the election, requiring the Director of Elections to include the full legal
text of a measure in the voter information pamphlet. the Director of Elections may in his or
her discretion omit the text or, in consultation with the City Attorney, prepare a fair and
impartial excerpt of the text to include in the voter information pamphlet.
(A) If the full legal text of a measure is printed in the voter information
pamphlet, the Department of Elections shall cause to be printed immediately below the Ballot
Simplification Committee digest, in no less than 10-point bold type, a statement substantially as
follows: "The above statement is an impartial analysis of Measure . The full text of this measure
appears at page (insert page number)."
(B) If less than the full legal text of a measure is entirely omitted from printed
in the voter information pamphlet, the Department of Elections shall:
(i) cause the full legal text to be posted on the Department's
website, provided to the Main Library and every branch library of the San Francisco Public
Library, and mailed to any voter upon request;
(ii) cause to be printed immediately below the Ballot Simplification
Committee digest, in no less than 10-point bold type, a statement substantially as follows: "The above
statement is an impartial analysis of Measure . An excerpt of the text of this measure
appears at page (insert page number). The full text of this measure is available online at
(insert website address) and in every public library. If you desire a copy of the full text of the

1	measure to be mailed to you, please contact the Department of Elections at (insert telephone number
2	and email address) and a copy will be mailed at no cost to you."; and
3	(iii) cause to be printed immediately below the excerpt of legal text
4	in the voter information pamphlet, in no less than 10-point bold type, a statement substantially
5	as follows: "The text above contains the first 20 pages of Measure but does not include
6	the remaining pages of the measure. The pages that have been excluded may include
7	important information that could be useful to voters, and the Department of Elections
8	encourages voters to review those pages as well. The full text of this measure is available
9	online at (insert website address) and in every public library. If you desire a copy of the full
10	text of the measure to be mailed to you, please contact the Department of Elections at (insert
11	telephone number and email address) and a copy will be mailed at no cost to you."
12	(C) If an excerpt of the legal text of a measure is printed in the voter
13	information pamphlet, the Department of Elections shall cause to be printed immediately
14	below the Ballot Simplification Committee digest, in no less than 10-point bold type, a
15	statement substantially as follows: "The above statement is an impartial analysis of Measure
16	An excerpt of the text of this measure appears at page (insert page number). If you
17	desire a copy of the full text of the measure, please call the Department of Elections at (insert
18	telephone number) and a copy will be mailed at no cost to you." Additionally, the Department
19	of Elections shall cause to be printed immediately preceding the excerpt of the text a
20	statement substantially as follows: "The text printed below is an excerpt of the full text of
21	Measure If you desire a copy of the full text of the measure, please call the
22	Department of Elections at (insert telephone number) and a copy will be mailed at no cost to
23	you."

Measures, and the material specified in this Section relating to said measures, shall be printed in the voter information pamphlet in the same order in which designated upon the ballot.

If space allows, the items specified in Subsection (c)(1) to (c)(5) of this Section shall be printed together on the same page of the voter information pamphlet. This page shall be known as the "ballot measure title page." The ballot measure title page shall also indicate: the page number at which the full text of the measure is printed; the page number at which the arguments for or against the measure are printed; and, if applicable the page number at which the definitions of terms appearing on ballot measure title page are printed.

The format of the voter information pamphlet shall be determined by the Director of Elections, subject to the approval of the Ballot Simplification Committee.

Section 2. Effective Date. This ordinance shall become effective 30 days from the date of passage.

Section 3. This section is uncodified. In enacting this Ordinance, the Board intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation, charts, diagrams, or any other constituent part of the Municipal Elections Code that are explicitly shown in this legislation as additions, deletions, Board amendment
