3 **Ordinance authorizing settlement of the lawsuit filed by Daniel Wong, Elaine Mak, and**  
4 **Carolyn Wong against the City and County of San Francisco for \$450,000; the lawsuit**  
5 **was filed on October 28, 2019, in San Francisco Superior Court, Case No. CGC-19-**  
6 **580302; entitled Daniel Wong, et al. v. City and County of San Francisco, et al.; the**  
7 **lawsuit involves alleged personal injuries from a vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Daniel Wong, et al. v. City and County  
12 of San Francisco, San Francisco Superior Court, Case No. CGC-19-580302 by the payment  
13 of \$450,000. The lawsuit involves alleged personal injuries sustained from a vehicle collision.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 October 28, 2019, and the following parties were named in the lawsuit:

16 Plaintiffs: Daniel Wong, Elaine J. Mak, individually and as Guardian Ad Litem for  
17 Carolyn Wong; Defendants: City and County of San Francisco, Jose Nava Aduviso.
