3 Resolution authorizing the Department of the Environment to accept and expend grant  
4 funds, available only for public agencies in California, in the amount of \$110,880 from  
5 the California Air Resources Board for the purpose of upgrading Compressed Natural  
6 Gas (CNG) fueling stations at Cesar Chavez and Golden Gate Park.

8 WHEREAS, the Board of Supervisors for the City and County of San Francisco  
9 enacted the "Healthy Air And Smog Prevention" Ordinance in 1999 to reduce emissions from  
10 the City's fleet vehicles in an effort to promote clean air and to protect public health; and,

11 WHEREAS, the Board of Supervisors for the City and County of San Francisco  
12 adopted the Sustainability Plan for the City and County of San Francisco which states that  
13 "[a]chieving and maintaining good air quality is crucial to the public health and economic  
14 vitality of San Francisco" ; and,

15 WHEREAS, in 2003, the Board of Supervisors for the City and County of San  
16 Francisco amended the Environment Code by adding Section 404 to develop the City's  
17 Compressed Natural Gas fueling infrastructure; and,

18 WHEREAS, Upgrading CNG fueling stations for City vehicles will enhance air quality in  
19 San Francisco and will enable City employees to fuel the City's CNG fleet faster; and,

20 WHEREAS, This grant ensures there is greater access to CNG in the western part of  
21 the City; and,

22 WHEREAS, Funds from this grant will be used to support city departments in  
23 performing actions they would need to perform without grant funds, and;

24 WHEREAS, This grant includes \$11,088 for indirect costs, and;

25 WHEREAS, This grant does not require an ASO amendment; and




