Since 2019 the college has been cutting vital programs and offerings, thus eliminating educational opportunity and lowering enrollment.

MORETHREATS TO REVENUE "Student Centered" Funding Formula (SOFF)



- A base allocation based on FTES
- A supplemental allocation based on the numbers of students receiving a College Promise Grant, Pell Grants and students covered by AB 540.
- A student success allocation based on outcomes

Ongoing need

Funding need is determined by the breadth and depth of CCSF's educational offerings.

Revenue needed projections = 7,732 class sections with the capacity to serve at least 22,500 FTES.

Three-year average enrollment demand was 22,500 FTES prior to the 19/20 class cuts that caused a decline.
