AUTHORIZING THE MAYOR'S CRIMINAL JUSTICE COUNCIL TO ACCEPT AND EXPEND FUNDS IN THE AMOUNT OF \$250,000 FROM THE U.S. DEPARTMENT OF JUSTICE OFFICE OF JUSTICE PROGRAMS (OJP) ,UNDER THE WEED AND SEED PROGRAM, TO DEVELOP AND IMPLEMENT A MULTI-AGENCY PROGRAM TO COORDINATE THE DELIVERY OF PUBLIC SAFETY AND SOCIAL SERVICES IN THE MISSION DISTRICT ( THE TARGET AREA), IN ORDER TO COMBAT JUVENILE CRIME, SUBSTANCE ABUSE AND HIGH TRUANCY RATES, AND TO PROVIDE A SAFE ENVIRONMENT FOR YOUTH AND FAMILIES IN THE TARGET AREA.


WHEREAS, The Weed and Seed program is a national, federally funded, community based program administered by the U.S. Department of Justice OJP; and,

WHEREAS, on May 28, 1998 the U.S. Department of Justice OJP awarded the Mayor's Criminal Justice Council of the City and County of San Francisco \$250,000, under the Weed and Seed program, to implement a multi-agency strategy supporting increased community policing, the development of a safe haven for youth and families, and the formation of community crime prevention partnerships in the target area; and,

WHEREAS, the entire award by the U.S. Department of Justice OJP, under the Weed and Seed program, funds direct services, it is requested that indirect costs be waived; now, therefore, be it

RESOLVED, That the City and County of San Francisco hereby authorizes the Director of the Mayor's Criminal Justice Council to accept and expend \$250,000 from the U.S. Department of Justice OJP, under the Weed and Seed program, to develop and implement the Weed and Seed program in the target area.
