2 AMENDING THE SAN FRANCISCO TRAFFIC CODE BY ADDING SECTION 203.5  
3 ESTABLISHING THE RATE FOR MOTORCYCLE PARKING METERS.

5 Be it ordained by the People of the City and County of San Francisco:


6 Section 1. Article 3 of the San Francisco Traffic Code is hereby amended by adding  
7 Section 203.5 to read as follows:

8 SECTION 203.5 PARKING METER RATES--MOTORCYCLES. The hourly rate for  
9 motorcycle parking meters for the various Parking Meter Areas shall be as follows:


- 10 (a) Parking Meter Area One shall have an hourly rate of twenty-five cents.
- 11 (b) Parking Meter Area Two shall have an hourly rate of fifteen cents.
- 12 (c) Parking Meter Area Three shall have an hourly rate of ten cents.
- 13 (d) Parking Meter Area Four shall have an hourly rate of fifteen cents.

14 All motorcycle parking meters shall be capable of accepting five-cent, ten-cent, and twenty-five  
15 cent coins. The amount of time given for these denominations shall be prorated on the basis  
16 of the hourly parking meter rate. The maximum time period permitted for parking at any  
17 motorcycle parking meter, whether operational or broken, on the posted days and during the  
18 posted hours of its operation shall correspond to the time designated on the parking meter.




