3 Ordinance authorizing settlement of the portion of the lawsuit filed by Mary Anne Short/
4 Robert Short against the City and County of San Francisco for \$160,000; the lawsuit
5 was filed on January 31, 2005, in San Francisco Superior Court, Case No. 436930;
6 entitled Jane Martin, et al. v. City and County of San Francisco, et al.

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the portion of the action
9 entitled "Jane Martin, et al. v. City and County of San Francisco, et al." San Francisco
10 Superior Court, Court No. 436930, as it relates only to co-plaintiffs Mary Anne Short/Robert
11 Short, by the payment of \$160,000, and excluding the claim by these plaintiffs for attorney's
12 fees, costs and interest, which will be addressed in later proceedings.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiffs Mary
15 Anne Short/Robert Short and Defendant City and County of San Francisco.
