7 WHEREAS, Eugene Coleman received an Honorable Discharge for serving his  
8 country in the United States Army's 101<sup>st</sup> Airborne Division from 1956 through 1959; and,

9 WHEREAS, Eugene Coleman received his Bachelor of Arts in Sociology from Findlay  
10 College, Ohio, in 1964; and,

11 WHEREAS, Eugene Coleman began a lifetime of professional public service in Ohio  
12 as a Social Worker, Supervisor of Employment Field Coaches, and Executive Director of  
13 Project Impact; and,

14 WHEREAS, Eugene Coleman continued his work on behalf of our most vulnerable and  
15 neediest residents in Southern California, first as a Probation Officer in Los Angeles County  
16 and later as a Community Liaison between the City of Inglewood and its citizens; and,

17 WHEREAS, In 1972 Eugene Coleman began over three decades of tireless work for  
18 San Francisco's residents as Director of Emergency School Assistance Program at the  
19 Western Addition Community Center, where he served mostly African-American and  
20 Japanese youth; and,

21 WHEREAS, For over a decade Eugene Coleman served as Executive Director of the  
22 Canon Kip Community House in the South of Market, a multi-service neighborhood center  
23 that served a diverse senior, family, and youth population; and,

1           WHEREAS, In his time at Canon Kip Community House, Eugene Coleman ran the  
2 city's first senior para-transit program; and,

3           WHEREAS, Since 1984 Eugene Coleman has provided exemplary service as an  
4 employee of the City and County of San Francisco, first as an Ombudsperson and Senior  
5 Planner at the San Francisco Department of City Planning and then, for the past eighteen  
6 years, as Deputy Director of the Mayor's Office of Community Development; and,

7           WHEREAS, Eugene Coleman has gone above and beyond the call of duty in his work  
8 for the City and County of San Francisco, serving on the City-Wide Alcoholism Advisory  
9 Board, the Local Homeless Coordinating Board, and the Mayor's Affordable Housing Task  
10 Force, among others; and,

11           WHEREAS, In his work for the City and County of San Francisco, Eugene Coleman  
12 has overseen the successful implementation of housing, land use, economic development,  
13 employment and training, and social service programs; and,

14           WHEREAS, Eugene Coleman has coupled his professionalism and fiscal responsibility  
15 for a department that allocates millions of dollars annually to community organizations with a  
16 calm, open, warm, positive demeanor; and,

17           WHEREAS, In addition to his professional work, Eugene Coleman has offered an  
18 endless supply of his own time, energy, and heart to numerous San Francisco community  
19 based organizations that work to improve the quality of life for all of our residents, including  
20 Baker Places, St. Anthony's Foundation, 409 House, and the Friendship House Association  
21 of American Indians, among others; and,

22           WHEREAS, Through his work with leading African-American organizations, including  
23 the Black Leadership Forum, Bay Area Association of Black Social Workers, and Black Men  
24 of Action, Eugene Coleman has demonstrated an unshakable commitment to the African-  
25 American community; and,


