9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Jose Garcia v. City and County of San
12 Francisco, et al., United States District Court, Case No. 12-cv-2443 by the payment of
13 \$50,000 and waiver of the \$16,509 San Francisco General Hospital lien.

14 Section 2. The above-named action was filed in United States District Court on March
15 16, 2015, and the following parties were named in the lawsuit: plaintiff, Jose Garcia;
16 defendants City and County of San Francisco and Officer Ryan Jones.






