20 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48
21 on-sale general public premises license from 711 Market Street to 1419 Fillmore Street
22 for Pascal B. Thiam for Savanna Jazz, LLC, will serve the public convenience and
23 necessity of the people of the City and County of San Francisco.

24 Conditions: (1) The petitioner(s) shall be responsible for maintaining free of litter
25 the area in front of and adjacent to the premises over which they have control; (2)

1 Entertainment provided shall not be audible beyond the area under control of the
2 licensee.


