

1 [Funds to support HIV rapid testing and counseling in drug abuse treatment programs.]

3 **Resolution authorizing the San Francisco Department of Public Health (DPH), to accept**
4 **and expend retroactively a grant in the amount of \$18,676 from the University of**
5 **California, San Francisco (UCSF), the primary contractor, with funds from the National**
6 **Institutes of Health, to support a study of HIV rapid testing and counseling in drug**
7 **abuse treatment programs, for the period of September 1, 2007 through August 31,**
8 **2008.**

10 WHEREAS, UCSF is the recipient of a grant award from the National Institutes of
11 Health (NIH), for a project titled "HIV Rapid Testing and Counseling in Drug Abuse Treatment
12 Programs in the U.S.;" and,

13 WHEREAS, It is considered in the best interest of NIH, UCSF, and DPH to participate
14 in this project; and,

15 WHEREAS, UCSF has agreed to reimburse DPH in the amount of \$18,676 under the
16 terms of this agreement for the period of September 1, 2007 through August 31, 2008; and,

17 WHEREAS, As a condition of receiving the funds UCSF requires DPH to enter into an
18 agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of
19 Supervisors in File No. 080672, which is hereby declared to be a part of this
20 resolution as if set forth fully within; and,

21 WHEREAS, The grant does not require an ASO amendment and partially reimburses
22 the department for one existing positions, a Senior Physician Specialist (Job Class 2232) at
23 .05 FTE for the period of September 1, 2007 through August 31, 2008; and,

24 WHEREAS, A request for retroactive approval is being sought because DPH did not
25 receive the required documents from UCSF until May 1, 2008; and,

1 WHEREAS, The budget includes a provision for indirect costs of \$2,001; now
2 therefore, be it

3 RESOLVED, That DPH is hereby authorized to accept and expend retroactively a grant
4 in the amount of \$18,676 with UCSF, the primary contractor, for services under the project
5 entitled "HIV Rapid Testing and Counseling in Drug Abuse Treatment Programs in the U.S.;"
6 and, be it

7 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
8 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
9 be it

10 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
11 agreement on behalf of the City; and, be it

12 FURTHER RESOLVED, That the Controller is directed to designate all positions
13 funded under this agreement as "G" or grant-funded positions which would terminate when
14 the agreement expires.


