

1 [Grant funds to support the California School Health Association project.]

3 **Resolution authorizing the San Francisco Department of Public Health (DPH), to**
4 **retroactively accept and expend grant funds in the amount of \$23,423 from the San**
5 **Francisco Public Health Foundation to partially pay the salary and fringe benefits for an**
6 **Assistant Health Educator to work at the Balboa Teen Health Center and to support the**
7 **California School Health Association project; for the period of March 1, 2007 through**
8 **June 30, 2008.**

10 WHEREAS, The San Francisco Public Health Foundation received a grant award from
11 the Public Health Institute/California School Health Centers Association, in the amount of
12 \$46,000 for the California School Health Association project; and,

13 WHEREAS, The San Francisco Public Health Foundation set aside \$23,423 of this
14 award for providing salary and fringe benefits for a DPH Assistant Health Educator (.2 FTE),
15 for the period of March 1, 2007 through June 30, 2008; and,

16 WHEREAS, The San Francisco Public Health Foundation has awarded these grant
17 funds to DPH to fund this staffing; and,

18 WHEREAS, The grant does not require an ASO amendment and partially reimburses
19 DPH for an existing position, Assistant Health Educator (Job Class 2819), at .2 FTE, for the
20 period of March 1, 2007 through June 30, 2008; and,

21 WHEREAS, DPH proposes to maximize use of available grant funds on program
22 expenditures by not including indirect costs in the grant budget; now, therefore, be it


23 **RESOLVED**, That the Board of Supervisors hereby waives inclusion of indirect costs in
24 the grant budget, and, be it

1 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
2 expend \$23,423 from the San Francisco Public Health Foundation; and, be it

3 FURTHER RESOLVED, That DPH is hereby authorized to accept retroactively and
4 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
5 be it


6 FURTHER RESOLVED, That the Controller is directed to designate the positions
